## Time Academy: A Time Policies' Toolbox for Local Authorities

The online sessions, which can be retrieved [here](#), were open to civil servants, municipal leaders and urban practitioners.

### How to Identify Existing Time Policies in My Local Government

The first session began on June 30 with an introduction to time policies and explanation of the methodology; case study from Barcelona Metropolitan Area on how they applied their framework to understand time policies at the metropolitan level; Practical implementation of the methodology within 3 contexts (1) Paid and Unpaid Working Time, (2) Time for Social Sustainability, (3) Time for Formal and Informal Leisure.

To wrap it up, this first session provided a comprehensive methodology for revealing time-related policies that influence urban and territorial organisation. Participants systematically assessed their institution's temporal governance across 7 domains, including: equality, commercial regulation, nighttime services, and mobility; gaining tools for self-evaluating the presence of existing time policies.

### Evaluating Time Policies Through Evidence-Based Frameworks

In the second session on Tuesday 1 July, we addressed how municipalities can develop rigorous, time-sensitive evidence systems that blend quantitative metrics (e.g., time-use surveys) with qualitative well-being indicators, drawing on global best practices and addressing institutional barriers. Speakers came from the Barcelona City Council and the Municipality of Bolzano.

### Designing Cross-Government Time Policies at Local and Regional Level

In the 3rd session of the Time Academy, mechanisms to maintain political commitment to temporal governance reforms while overcoming institutional divides were explored. The Time Use Initiative explained how to identify political decision-makers within an institution; the Catalan Government provided a case study on the Catalan Government on Network of Professionals for Equity in Employment; and the Barcelona Provincial Council presented how local governments can implement transversal time plans.

### Time Policies for Climate Action

The fourth session was designed to analyse and apply how time is useful for identifying climate mitigation and adaptation measures. It reviewed how to identify "time generators" affecting schedules and mobility, and how to coordinate the rush hour, as well as how to classify time policies according to their effect in climate mitigation or adaptation. Speakers came from Rennes Metropolis and Milan City Hall.

As a conclusion from the whole event, there are already many governments implementing time policies, but there is room for developing the field. Many institutions and governments around the world are interested in learning more about specific time policies. Implementing an action plan to address a new time organisation that includes an internal evaluation of existing time policies, as well as including roles such as Time Policy Officers within local and regional governments, will be a path forward.

An evaluation survey was sent to all participants. From it, it can be seen that the whole programme for the **Time Academy was evaluated as a success with a 4,7/5**, and specifically Sessions 2 and 3 were the best evaluated, with 4,6/5. When it comes to evaluating the participation platform, all participants found it useful to use, and in terms of the dynamics for the workshop part, the best evaluated was from Session 2, with a 4,8 — with participants asking questions directly to speakers in breakout rooms, having time for the debate. Finally, when asked about accessibility (automated subtitles), in general, all participants used the option, although some of them seemed not to have been fully able to use them.

All Time4All 2.0 partners also supported the dissemination of the event, resulting in a great success in terms of registration and participation. Due to that, it has been possible for the event to **reach up to 13 eligible countries**, or 229 participants, beyond the 9 partner ones, or 224 participants.

Given that one of the main goals of the project is to raise awareness among local governments about time policies —even beyond the consortium— the partnership is continuously working to engage and sensitize local authorities. For this reason, the invitation to the Time Academy was extended by our network to all interested cities. This has successfully resulted in the involvement of 23 additional countries (as stakeholders, even though they are not formal project partners).
